EMS Council Rep.	Larry Barter, EMS Council Rep was in attendance. As there are many Advanced EMT's that are Volunteers, it would be good to have a policy in place regarding the blood draws. That practice would require the "Volunteers" to take off work, sometimes even years later, to go to court. WCA Services is also looking for EMT of the year.
