	Dennis talked about how they put a demonstration on with the Kiwanis Club last year and this year the Kiwanis are
	doing a "Dice Run" fund raiser for the dive team. Denny said they bought new dive vests from a grant they received.
Hazmat Coordinator	Dan Imfeld stated they are doing training on a new piece of equipment on Saturday. In February there will be a State
	Hazmat Seminar and a Regional Seminar in April. There have been no recent Hazmat Calls. Recently a 24' tandem axle
	trailer was purchased for Mass Casualty Incidents. It was purchased without shelves, but the Rangers will install them where they are needed.
Training	Bill Johnston stated there was a class the other night which was cancelled for weather. Bill reported on all upcoming
Coordinator	courses available. More classes are coming down the pipeline in addition to a daytime Scene Support class.
Tech Rescue	Charlie Smith started a Rescue Tech Basic Class at JCC last week. The Technical Rescue Team will be training in Erie
Coordinator	County with their indoor training on the January 28 th , 2012. They also will be training with the Niagara County Team.
	There is a State Wide Technical Rescue Team Leaders Meeting in the spring.
Fire Coordinator	Julius Leone spoke early in the meeting as he had to leave for Syracuse.
	On Feb 1 st we will have a HASNY meeting which will help with our Comprehensive Emergency Plan. This meeting will help us identify potential problems in our county like we did 5 years ago.
	On January 31, 2012 there will be a Radio Advisory Meeting will meet to see where we are going with radios.
	We received an EOC Grant. Mike Mendez has been working on this. We received \$50,000 to upgrade technology and in lieu of the tornadoes we have had recently we will be able to update windows and doors.
	The Multijurisdictional Mitigation Grant is important to the communities so identified problems can be worked on.
	Julius reported that the Murphy Training Center lease was signed by all entities and we should have a copy of the 40 year lease any time.
	We have received the MERV Trailer. We hope to see it in service in the next 3-4 months. There is a problem with the

	Fire Police truck. Cassadaga offered a vehicle to them but it would be cheaper to fix the one we have.
	We received monies from Homeland Security to set up a command unit on a truck. We will be working on that.
	Chautauqua County Search Team has been in effect since 1999. The team has come to the county to see if they could become part of the Technical Rescue Team. Charlie Smith and David Pachan will discuss more details in the future.
	There will be a meeting next week on EMD. The issues were identified and they will look at that again.
	Julius said we have a staffing change we want to talk about. Jon Stahley has announced he is going to retire. He has spent 30 years as 4 th Battalion and Deputy Coordinator. Jon has made a huge difference in fire service. Skip is moving up to the Deputy Coordinators position so we will be looking to replace the 4 th Battalion Coordinator. It is Jon's desire to stop in 3 months.
