Codeplugs Updates

Estimated Timeframe - QUARTER 2 OF 2023

Beginning JUNE 23rd 2023, Radio Shop will be rolling out new codeplugs on Fridays to the FDs. We will be reaching out to Chiefs to schedule times at fire departments, so that we can try to get all radios at fire hall for that day.

Hospital Trunked Radios

Estimated Timeframe – 2024

- First step, roll out updated Codeplugs with Hospital Talkgroups, then get HOSPITAL TRUNKED radios ordered and installed at hospitals.
- We will NOT be decommissioning the systems (MED1, MED 2, MED7) that are currently used to call into the hospitals, after the new talk-groups are active. So that units that are not on our trunked system, can continue to talk to the hospitals.

Vehicular Repeaters (SICG Grant)

Estimated Timeframe - QUARTER 4 OF 2023

- Get info to your coordinators for what apparatus (FIRE/EMS, not chief vehicles) your department plans on having repeater installed in, type of radio is in that unit, or if you department is not interested in receiving a repeater.
