### 2019 Seminar Series

### "Tactical Tasks and Tips in Truck Work" With Lieutenant Mike Ciampo, FDNY

On February 11, 2019 a three-hour program entitled "Tactical Tasks and Tips in Truck Work" was presented to a large group of firefighters from across the region. The program was sponsored by the New York State Association of Fire Chiefs and was held in the Emergency Operations Center classrooms at 2 Academy Street, Mayville, NY.



The presenter was Michael N. Ciampo, a lieutenant in the Fire Department of New York (FDNY). Previously, he served with the District of Columbia Fire Department and the Wyckoff (NJ) Volunteer Fire Department. Ciampo has a Bachelor of Arts degree in fire science from John Jay College of Criminal Justice. He wrote

the ladder chapter and co-authored the ventilation chapter for Fire Engineering's Handbook for Firefighter I and II. Ciampo is featured in Fire Engineering's "Bread & Butter Operations Ground Ladders DVD and online "Training Minutes" truck company videos and writes the column "On Fire" for Fire Engineering.

Ciampo covered how the "LOVERS-U" functions (ladders, overhaul, ventilation, forcible entry, rescue, search, and utility control) can be accomplished with limited manpower and resources requiring firefighters to adapt to the conditions faced and overcome the challenges of the situations. During the program Ciampo showed through video and lecture numerous street proven tactics and tips that will increase overall skill levels, improve safety, help enhance tactical performance, while saving time and energy when operating at incidents. Ciampo showed techniques that included performing new and improved leg lock maneuvers, unusual ladder raises when faced with obstructions, hand and power tool usage strategies, ventilation cutting options, and apparatus set-up, positioning, and operation.

Monday, May 20, 2019 is the day set aside for the Fire Service to express its concern to law makers in Albany. Fire Service Government Affairs Day is that day in May when the Fire Service in New York State goes to Albany and meets with their representatives to express their collective and individual concerns on legislation of all types in New York State. From laws and rules that need eliminated or amended to new laws and rules that need to be created addressing issues that affect fire service operations, firefighters and the safety of the citizens they protect.

Locally, in Chautauqua County, John Griffith, Director of Emergency Services, suggests that county fire organizations contact the New York State Association of Fire Chiefs (NYSAFC) to coordinate scheduling of NYS Legislator visits to ensure you can get an appointment with those you wish to speak with. John also recommends coordinating with his office for the purpose of ride sharing. Class A uniforms are the preferred style of dress although a suit and tie would also be acceptable.

The NYS Fire Service Alliance is a collective group of six fire service organizations in the state that have joined together on a list of common initiatives. These are; Association of Fire Districts of the State of New York; FASNY; NYSAFC; The Volunteer Fire Police Association of the State of New York; County Fire Coordinators Association of the State of New York; New York State Fire Marshals and Inspectors Association.

#### This is the list of the agreed upon major initiatives:

2019 New York State Fire Service Alliance - Issues of United Concern

- Chapter Amendments to GML 205cc, clarifying or modifying as appropriate the verification requirements so that benefits may be extended to intended firefighters with five years of interior service to their respective departments.
- Emergency Medical Cost Recovery allow fire departments and districts currently unable to recover the cost of providing pre-hospital EMS service from insurers, Medicare and Medicaid in a similar manner as for-profit, not-for-profit and municipal providers are able to recover costs.
- Seek an increase in VFBL/VAWBL benefits for partial permanent disability and seek parity with worker's compensation benefits for volunteer firefighters and volunteer ambulance workers in the event they are injured in the line of duty.
- Pursue legislative and administrative actions for building owners who perform modifications or conversions without obtaining the prescribed permits for single or multi-family occupancies which endangers the welfare of the occupants and fire or emergency responders in the pursuit of their duties.
- Establish a prohibition on the sale of upholstered furniture which employs the use of carcinogenic flame-retardant chemicals.

If your organization has additional concerns, the Fire Service Government Affairs Days is another avenue for you to present them to the Legislators in Albany.

## 12 Lead Training Held



On Saturday February 16, 2019 an in-service for the purpose of credentialing Emergency Medical Technicians in the use of 12 Lead devices was held at the Emergency Operations Center at 2 Academy Street in Mayville.

Late last year Catholic Health-Mercy Hospital of Buffalo provided 12 Lead units to several departments through a grant application process. Training was to have been held shortly after in January, but the winter weather conditions resulted in a postponement until recently.

#### The instruction was provided by Emily Rowles-Saraeni AEMT-P, NYSCIC, the EMS Liaison for Mercy Hospital.

The departments have several more procedural steps to go through before the 12 Leads will able to be placed into service. The training held was just one of those steps.

**Buffalo, NY**— Recognizing an urgent community need that could help save lives for heart attack patients, Mercy Hospital of Buffalo recently donated EKG machines to 18 area volunteer fire departments located in outlying, rural areas of Western New York. The need was identified at an American Heart Association (AHA) Mission: Lifeline conference last June where physician and EMS leaders discovered that many local volunteer fire departments do not have EKG machines and lack the funds to purchase this critical equipment.

Working together, Mercy Hospital's EMS Liaison Emily Rowles, Director of Neuroscience Clinical Services Nancy Stoll, and Stroke Coordinator Alexandria Foley; along with Catholic Health Director of Grants Rachael Nees, were able to secure grant funding to purchase and donate the EKG machines. The portable units will help the first responders check a patient's heart rhythm in the field to determine if they may be having a heart attack. The hospital will also provide EMS training on the use of the EKG machines.

"By giving our rural EMS providers this lifesaving tool, we will be able to expedite care to heart attack patients, which can lead to better outcomes," said Dr. Ali Masud, an interventional cardiologist at Mercy Hospital, who was a key participant of the EKG discussion at the AHA conference.

Mercy Hospital hosted an event on December 10 where the EKG machines were blessed and distributed to Fire Department officials from the following departments in Chautauqua County: Ashville, Celeron, Ellery Center, Ellington, Findley Lake, Forestville, Ripley, and Stockton. In addition, the following Western New York departments also received EKG machines: Canaseraga, Independence, Portville, Clarksville, Machias, Andover, Marilla, Arcade, Cowlesville, and Hamburg.

### Forestville Gets a New Engine



The Forestville Fire Dept Inc has just placed in service a 1992 Pierce Lance Engine. It's a 6 man cab with a 1500 GPM top mount pump. It carries 750 Gallons of water with a 30 gallon foam tank. It has a

350hp Detroit engine with an automatic transmission. It also comes with a 6KW generator.

Its replacing a 1990 Pierce International 2 man cab. This engine was purchased from the Ellicott Creek Fire Dept in the Town of Amherst.

#### Panama Gets A New Engine 382

Panama's new Engine 382 is a 1996 HME/ Southern Coach 10-man cab truck with a 1500 gpm top mount Hale pump and is powered by a Detroit 9.2 series diesel engine with a 5 speed Allison automatic transmission. It was



purchased from Wysox fire company in Wysox Pennsylvania and is a twin to Mayville Engine 251. Both units originally came from Seaside Heights, New Jersey.

#### **Celoron Hose Company Brings Home A new Edition**



Celoron Hose Company was set to receive their new Sutphen 70 foot Platform on Friday February 8, 2019.

The new unit, is officially a SP-70 powered by a Cummins L9 450HP with an Allison transmission. For the pumping side there is a Hale QMAX-1500 GPM pump and a 500 gallon UPF poly water tank supplying two crosslays of 1-3/4 of 200 feet each with a third crosslay of 200 feet of 2-1/2 inch. There are two TFT Monsoon Monitors at the platform with one having manual controls and the other fitted with electric controls for remote operations as needed. The unit is designed to carry 1,000 feet of 4 inch supply as well as an additional 300 feet of 2-1/2 inch hose. The truck carries 85 feet of ground ladders and utilizes a Harrison 6kw hydraulic generator to provide additional power for auxiliary lighting and other equipment.

The new T-321 has an overall listed height of 10 foot 9 ¼inches. The previous apparatus is still in the county, but that story is for another day.

The Lakewood Fire Department recently purchased a 2018 Sutphen SPH100, 100-foot midmount platform with dual water cannons. It has a 300-gallon tank with a /2000 gpm pump and is powered by a Cummins ISX12- 500 HP. The cost of the unit was \$1,174,000.



#### Recent Retirements & Promotions in the Jamestown Fire Department



The Jamestown Fire Department recently saw a change in its command structure. Deputy Fire Chief Chester (Chet) Harvey retired after 34 years of service. Chet started as a firefighter in 1984 working his way up through the ranks to Lieutenant in 1992, Captain in 1998 and Battalion Fire Chief in 2004. He assumed the top leadership role as Deputy Fire Chief in 2015.

Battalion Fire Chief Samuel Salemme was selected to take over the top spot from Harvey. Sam was hired as a firefighter in 1990. He was promoted to Lieutenant in 2000 and Battalion Fire Chief in 2005. Sam assumed the duties of Deputy Fire Chief in early December. Sam is the current Chairman of The County EMS Council, the First Vice Chair of the Chautauqua County Fire Advisory Board as well as serving on the Chautauqua County Radio Advisory Board.


